4. Welcome by William Calo --

- No new members or career changes for members

Stakeholder spotlight – Crystal Balberchak, LPN, WellSpan Medical Group – Age 9 Initiation

- Worked to get age 9 embedded in EMR system for WellSpan Medical Group
 - Schedule second dose of HPV vax at front office before leaving the office. Auto-prompt within their scheduling system! Shared new process during a lunch and learn with Medical Group. Changed the narrative to focus more on cancer prevention than sex
 - Co-brand with ACS to strength recommendation of the HPV vax next
- William Calo asked a question re: parents involving their child in vax discussions
Crystal thinks children are getting more involved and have been exposed to the commercials re: age 9 vaccination. Have seen an uptick in teens taking an initiative for the vax

William Calo shared experience from a national Clinical Advisory Board. It was shared that cancer messaging is effective with parents, but teens are more motivated by not getting genital warts.

Old Business by Pam Schauer —

PAIC and PIC Updates from the Annual meeting

Chelsea Bufalini shared about the two conferences that occurred at the Hershey Lodge in June. Topics focused on immunization across the state and focusing on sustaining programming relating vaccine uptake initiatives by different coalitions.
