## 9. Open Member Sharing & Any Action Steps by Chelsea & Pam —

- a. Paula Di Gregory Hep B event on the 18<sup>th</sup> Corporate Health Improvement Coalition is a recipient of the PAIC grant for immunization awareness. At annual meeting will do training with EXCITE to speak with vaccine hesitancy at UPT. Anticipate 22 attendees.
- b. Bufalini Will be launching a podcast study to promote HPV vaccine communication education with providers including physicians, NPs, and PAs across PA. A small pilot that will enroll 40 participants. Will be launching recruitment next month at PACHC event.
  - i. Katie Noss offered to make connections at event to help promote recruitment for podcasts.
- c. Mana Mozaffarian
  - i. Private practice in MA created a website to track what offices in each state are doing to promote the HPV vaccine (national dental immunization organization)
  - ii. State law allows providers to perform within their view of their scope of practice unless outright prohibited. Issues with legality of reimbursement for providing vaccines at dental practitioners
    - 1. Ex. If not explicitly prevented from giving vaccines, dentists (trained medical professionals) are able to administer the HPV vaccine within their scope of practice.
