Helen Hawkey – As a dental hygienist she has firsthand seen the impact of oral cancers and the long-term impacts of oral cancer. It’s important for dental to be at this table. She has two colleagues that have died from cervical cancer and has a personal connection.

Michael Goldstein – We have all been impacted by cancer in some way. In 2007, he was part of the Gardasil launch team, there’s a big importance on understanding the science and the impact of the vaccine on the community. It takes a team of public health champions to drive change from community advocates to policy change. The workgroup is made up of vaccine champions.

Katie Noss – PACHC – they have 400 health centers with a patient population that is facing some type of barrier to care. Prevention is key. Passionate about letting providers know what they can do to increase vaccination in this patient population

Nikki Johnston - education + being able to protect children against HPV related cancer + my two boys!

Pam Schauer – has worked for ACS for 23 years, it’s amazing to have something as simple as a vaccine to prevent cancer is amazing.

Rodeen Lechleitner - the Health System and Data Coordinator for PA's Breast and Cervical Early Detection Program so it matches with his work although his TRUE why is because of his 5-year-old daughter, Mauti Grateful- he wants to protect her and her friends.
