2	 Highlights from Prostate Cancer Awareness Month: Brenda shared that the Men's Health Workgroup held a webinar in partnership with Dr. Owens, with 140 registrants. Registrants can access the recording. Donna shared that ACS CAN Pennsylvania held a Changemakers webinar with Dr. Monica Baskin with UPMC's Hillman Cancer Center and the University of Pittsburgh; PA Representative and Chairman of the PA Legislative Black Caucus, Napolean Nelson; and Jim Williams, Chairman of the PA Prostate Cancer Coalition. Brenda and Donna shared that the PA Prostate Cancer Coalition held a Press Conference and Advocacy Day on 9/18/24 and welcomed House Insurance Majority Chair, Representative Patty Kim; Representative Justin Fleming; Deputy Sec'y of Health, Kristen Rodack; Dr. Gomella from Jefferson; and two survivors, also War Veterans. Georgia shared information about HB 531 (McNeill) and future discussions about language for 2025 – addressing PA case law requirements. Outreach to bill authors and sponsors is underway in preparation for 2025.
